4011	ALTERNATIVE FUELS (Caswell) Businesses; franchises; fuel providers that do not offer alternative fuels to franchised retail gasoline distributors; allow those service stations to buy those fuels from other distributors and refiners.
4069	TRANSPORTATION FUNDS (Mayes) Highways; bridges; movable bridges; provide specific funding each fiscal year from Michigan transportation fund. <i>(same as HB 4194 of 2005, HB 4779 of 2003, & HB 6221 of 2002)</i>
4173	ANNIE OAKLEY MEMORIAL TRAIL (Donigan) Highways; name; certain portions of US-127; designate as “Annie Oakley Memorial Trail”. <i>(same as HB 6113 of 2006)</i>
4300	LOGO SIGNAGE (Sheltrown) Highways; signs; logo program; expand to include “attraction” signs. <i>(same as HB 5632 of 2006)</i>
4310	COUNTY MULTIYEAR PLANS (LaJoy) Transportation; other; county multiyear plans; require township review. <i>(same as HB 4457 of 2005)</i>
4323	OFF ROAD VEHICLES (Sheltrown) Natural resources; other; operation of off-road vehicles on road shoulders; allow local jurisdictions to approve and create a fund for enforcement and environmental remediation.
4478	TRANSPORTATION FUNDS (LaJoy) Transportation; funds; deadline for projects eligible for funding through local match grant programs; extend. <i>(same as SB 360 of 2007)</i>
4534	RIDE YOUR MOTORCYCLE TO WORK DAY (LeBlanc) History and arts; other; “Ride Your Motorcycle to Work Day”; establish.
4556	TRANSPORTATION FUNDS (Mayes) Transportation; funds; date revisions; provide for.
4563	BORDER CROSSING (Tobocman) Local government, port authorities; border development and protection authority; create.
4599	HARRY GAST PARKWAY (Proos) Highways; name; renaming a portion of M-63; designate as “Harry Gast Parkway”
4608	5% BIODIESEL (Sheltrown) Transportation; other; requirement of 5% biodiesel to be included in fuel products; provide for. <i>(same as HB 5120 of 2005)</i>
4635	JACKSON COUNTY VETERAN’S MEMORIAL HIGHWAY (Simpson) Highways; name; renaming a portion of M-50; designate as the “Jackson County Veteran’s Memorial Highway”
4747	RAILROADS (Robertson) Transportation; railroads; abolishment of certain grade crossings; allow if fewer than 1,000 vehicles a day use that crossing. <i>(same as HB 4190 of 2005 and HB 6288 of 2004)</i>
4825	TRANSPORTATION FUNDS (Young) Transportation; funds; requirement for 50% of transportation contracts to be given to local municipality in which contract is located; establish.
4826	TOLL ROADS (Young) Highways; other; toll roads; allow.

4928	RIDERSHIP FARES (Agema) Transportation; funds; requirement for state subsidized transit agencies to supplement budget through ridership fares; provide for and provide penalties for noncompliance.
4979	ASSET MANAGEMENT (Hopgood) Transportation; other; transportation asset management; modify.
