Mechanics now may renew their certifications by mail or **online**. To renew online, go to www.Michigan.gov/sos and click on "Automotive-related Businesses" then "Information for Mechanics" for additional information. You will need your PIN number, the last five digits of your Social Security number, and a valid Visa or MasterCard.

Your Michigan mechanic certification will expire on the date shown in Box 4. To renew your certification by mail, please review the information in Boxes 1-6 for any errors and complete items 7-9. As you review the form, fill in any missing information or draw a line through any error and print the correct information.

IF YOU ALLOW YOUR CERTIFICATION TO EXPIRE you may not work as a certified mechanic. Also, you will be charged a late renewal fee of \$30.
