Student Record Layout

All records in the active student database submitted in the MEIS must conform to the following ASCII record layout; i.e., records must be 938 characters in length, with data variables conforming to the specifications given below. If the file length does not conform to this format, the error check application will reject the file.

Data Variable Specifications:

- Alpha – consisting of letters.
- Alphanumeric – consisting of letters and numbers.
- Boolean – consisting of either the numeral one or zero representing "true" or "false".
- Character – alphanumeric, punctuation marks, and special characters.
- Integer – a whole number as distinguished from a decimal.
- Date – numbers and slashes to represent the month, day, century, and year:
MM/DD/CCYY.
- Decimal – a numeric field containing a decimal point.
- DC (Default Code) – field is set to a given value unless otherwise changed by the user.
