(1) On 11/1/07, the second year of the three-year license cycle begins and this adds an additional year that the license has been expired so that six more hours are required. The third year begins 11/1/08 and adds six more hours to the relicensure requirement.

(2) Section 2504(9) of the Amended Code states:

(a) a license issued in the 2nd year of the 3-year cycle will need 12 hours of CE to renew.

(b) a license issued in the 3rd year of the 3-year cycle will need 6 hours of CE to renew.

Rule 213(4) Completion of continuing education for relicensure shall not qualify as completion of the continuing education requirement for the next license renewal.

(3) Due to 60 day late renewal capability, the relicensure application receipt date starts with January 1st of the next year.

(4) During a year in which all licenses expire, applications received after 7/1 will receive a license which will expire the next expiration period (i.e. 7/1/09 application receipt generates a 10/31/12 license.).
