## Types of Registrations and Licenses

There are two types of registrations and three types of licenses:

### Registrations

1. Specialty (non-farm use) fertilizer products
2. Soil conditioner products

### Licenses (one license covers all three uses per facility)

1. Agricultural (farm use) fertilizer manufacturer/distributors
2. Specialty fertilizer custom blenders \*NEW 3/30/07\*
3. Soil conditioner custom blenders \*NEW 3/30/07\*

## Registration

Fees are assessed at the rate of \$125 for each brand and product name of each grade per calendar year.

### Specialty Fertilizers

Any fertilizer distributed primarily for non-farm use, such as use in connection with home, gardens, lawns, shrubbery, flowers, golf courses, parks, and cemeteries.

### Soil Conditioner

Any substance that is used or intended for use to improve the physical characteristics of the soil. Soil conditioner does not include guaranteed plant nutrients, agricultural liming materials, pesticides, unmanipulated animal or vegetable manures, hormones, bacterial inoculants, and products used in directly influencing or controlling plant growth. A soil conditioner with nutrient value claims is considered a fertilizer.

### Groundwater Protection Fee

A groundwater protection fee of \$100.00 per registered product is assessed in accordance with 1994 Public Act 451, Part 87, Groundwater and Freshwater Protection, and Part 85, Fertilizers.

## License

Fees are assessed at the rate of \$100.00 per facility per calendar year.

### Fertilizer Manufacturer/Distributor

All firms that have their names and address on the labeling or invoicing for an agricultural (farm use) fertilizer distributed in the State of Michigan are required to obtain a facility license. A license is required for each of these facilities whether they are located in or out of the State of Michigan. Firms manufacturing only specialty (non-farm use) fertilizers do not need a license unless custom blending.

### Soil Conditioner & Specialty Fertilizer

\*NEW\* MARCH 30, 2007 – Allows a facility license in lieu of separate product registrations for custom blends only. This license only applies to mixes specifically requested by consumer prior to blending and this consumer is the end-user of the blend. The custom blender will need to document this request, mix only the amount requested and report this tonnage semi-annually. All pre-packaged and other non-custom blends of soil conditioners and specialty use fertilizers do not need a license must continue to be registered.
