

QI 4956 Error Return File

The Error Return File (4956) contains a header record, detail records that indicate which errors were found, and a trailer record. The instructions and formats of each are listed below.

QI Error Return File Header Format

This CMH QI Error Return File EDI Header is a single record that precedes the error report (Error Return File) that gives the entity that submitted data files detail on error detected by the QI Data Warehouse edits process.
