

# QUARTERLY NURSING HOME STAFF REPORT

(FY2009 Appropriation Bill - Public Act 246 of 2008)

**April 15, 2009**

**Section 708:** Nursing facilities shall report in the quarterly staff report to the department, the total patient care hours provided each month, by state licensure and certification classification, and the percentage of pool staff, by state licensure and certification classification, used each month during the preceding quarter. The department shall make available to the public, the quarterly staff report compiled for all facilities including the total patient care hours and the percentage of pool staff used, by classification.
