Locating the School Summary Report

Insert for Process Step 1

The first step is to locate your school Summary Report. This document will use sample reports, but you should be looking at your school's report as you follow along in the documents. Summary Reports come with the individual student MEAP and MME results and should be available at your school. If you cannot locate them, the School Summary Report is available on the Bureau of Assessment and Accountability (BAA) Secure Site at <https://baa.state.mi.us/meap/login.asp>.
