# III. APPROVAL OF JUNE 6, 2013, MEETING MINUTES

Fred Doelker noted that both he and Gary Bubar were present at the June 6, 2013, PTAC meeting. The meeting minutes were approved with those changes noted. Kevin Doty moved to approve minutes, as amended, seconded by Lori Richardson. Motion passed.

# IV. ADDITIONS TO AGENDA AND APPROVAL OF AGENDA

Ken Micklash made two additions to the agenda.

- A. Child restraint comments were added to section V of the agenda, as item 5.
- B. Backing up of school buses was added as an assignment for subcommittee work in section VIII, Sub-part A-2.

William Coaster moved to approve the agenda as presented/amended, seconded by Lori Richardson. Motion passed.

# V. OPENING COMMENTS/ANNOUNCEMENTS/PRESENTATIONS

- A. Michigan Department of Education (MDE) Initiated
  - Report on the adoption of federal mandated CDL skills testing
     (Tom Bryant and Kyle Binkley)

Tom Bryant and Kyle Binkley of DOS reported on the adoption of federal mandated Commercial Driver's License (CDL) skills testing. Michigan has adopted the recommendation by the Federal Motor Carrier Safety Division and has commenced testing ahead of the national mandate of 2015. The updated skills test requires more space to do some of the tasks. This has resulted in changes in the available testing facilities, including the elimination of some testing sites. DOS works to

ensure there are sufficient testers to meet demand. There are 106 certified trainers in the state. PTAC members were concerned about the demand for training for CDL skills due to turnover among drivers.

2. School Bus Inspection Status - Update - (Inspector Randy Coplin)

Inspector Randy Coplin of the Michigan State Police (MSP) reported that they completed 100 percent of the inspections in Fiscal Year (FY) 2013. The new inspection cycle started on September 1, 2013. Inspector Randy Coplin handed out a copy of the new inspection manual; new copies are being prepared for distribution. MSP will institute a recognition program. Focus for FY 2014 will be to complete 100 percent of the required inspections.

3. Information regarding the Michigan Association of Pupil Transportation (MAPT) Fall Workshop – (Gary Bubar)

Gary Bubar of MAPT reported on the Special Education Driver's Road-E-O held on October 5, 2013, in Lansing. He also noted that the National Association of Pupil Transportation meeting will be held on October 21-24, 2013, in Grand Rapids.

4. Update related to the National Association of State Directors of Pupil Transportation Services (NASDPTS) fall meetings to be held on October 18, 2013, in Grand Rapids – (Ken Micklash)

Ken Micklash reported on the upcoming NASDPTS annual workshop. Michigan is serving as host and has teamed with MAPT to provide some welcome packets to the members travelling to Michigan. Ken also arranged for three presentations to be made during the annual meetings. These include the University of Michigan and Office of Highway Traffic Safety Crash Data Project, MSP presentation on bus inspections, and a presentation on CDL medical testing revisions which will occur in 2014.

5. Child Restraints – (Ken Micklash)

Concern was raised because it has become known that a "waiver" was provided by a Head Start agency to a pupil transportation provider to move children under the age of four without proper restraints. Concern was expressed over this practice. PTAC agreed to develop an advisory practice and provide a recommendation at the next PTAC meeting on this issue. Ken will coordinate this project.

  - 1. Supervisor Continuing Education Update

William Coaster reported that Part I of the supervisor training is being taught. There have been excellent reviews on the training which can be delivered on demand. The training module is recorded and available for easy access when supervisors have the time to take the training. Part II of the training has been under development. Under the lead of Mac Dashney, Michigan Department of Transportation and MDE have been working on the Part II training. Part II will include information on safe routes to school, bus inspections, and public school/public transport collaboration.

 Beginning School Bus Driver Safety Education Curriculum – Unit IV Cell Phone Revision and Unit Objectives – (Lori Richardson)

Lori Richardson of Training Agency Association of Michigan (TAAM) provided an update. The objectives of the curriculum have been revised and re-phrased. It was noted that PA 36 on texting restrictions applies to all Commercial Drivers, including school bus drivers. This revision is also included in the curriculum training update.  Continuing Education School Bus Driver Safety Education Curriculum – Update – (Ken Micklash)

Ken Micklash provided a list of topics that are being covered in the upcoming training cycle. Gary Davis of the Eastern Upper Peninsula ISD is coordinating the development of this training program for TAAM and MDE.
