Owners of historic snowmobiles may elect to register their snowmobile as a historic snowmobile if all eligibility requirements are met. The registration has a one-time cost of \$50 and is non-expiring. Snowmobiles registered as historic snowmobiles are not required to have a snowmobile trail permit.

A single historic snowmobile decal is issued which is placed above or below the headlight or, if the historic snowmobile was not originally equipped with a headlight, on the forward half of the cowl above the footwell. Your new historic decal and registration will be mailed to you from Lansing.

**ELIGIBLE SNOWMOBILES:** Snowmobiles 26 years old or older and owned solely as a collector's item.

**LIMITATIONS OF USE:** Historic snowmobiles are limited to occasional use and for participation in club activities, exhibitions, tours, parades, and similar uses, including mechanical testing.

To register your snowmobile as an historic snowmobile you will need proof of ownership:

- 1) If already registered in your name, a copy of your registration.
- 2) If not registered in your name, one of the following:
  - a) The seller's snowmobile registration assigned to you. Liens must be terminated.
  - b) A bill of sale which includes the year, make, vehicle identification number, any registration number on the unit, and names and addresses of the buyer and seller. The bill of sale must be signed by the seller.
  - c) For a snowmobile valued over \$2,500, a surety bond.
  - d) For a snowmobile valued at \$2,500 or less applicant may complete an Ownership Certification.
  - e) A court order assigning ownership to you.

Submit your proof of ownership, this completed application, the \$50 registration fee, and 6% tax (if due) on the purchase price or retail value to the address below. Tax is not due if the snowmobile is already registered in your name or you purchased it from an immediate family member. Payment can be by check or money order payable to the State of Michigan.
