3. Accepted Bidders will be required, as a condition precedent to award of the Agreement, to furnish in the amount of 100% of the contract price, satisfactory Performance Bond and Payment Bond and Certificates of Insurance as required in the Project Manual.
4. Unless otherwise specifically set forth in Section 00880 of the Project Manual, this Project is subject to state sales and/or use taxes and Bidder is required to include such taxes in its Bid Proposal.
5. Barton Malow Company has been contracted by the Owner in the capacity of **Construction Manager** for the Project, and as such has the rights and obligations set forth in its contract with the Owner for those services, and shall act as representative of the Owner to the extent required/allowed under its Owner contract.
6. Bid Proposals will be **publicly** opened immediately following the due date and time for receipt of Bid Proposals by the **Owner at 33466 Garfield Rd., Fraser, MI 48026**, evaluated by Barton Malow Company, Owner and the Architect, with award presentations subsequently made by **Fraser Public Schools**.

8. There will be no pre-bid meeting for this project. Please direct all inquiries to Barton Malow Company.
9. No deposit for a document set is required. Each Bidder shall provide its shipper number for shipping fees if the Bidder desires to have plans sent by ground or air transportation. More than one set is available upon payment of printing and shipping costs of \$100 per set (non-refundable). Return the Bid Documents to the Barton Malow Company within twenty (20) days after opening of the Bid Proposals. Successful Bidders shall retain their set of Bidding Documents.
10. **Fraser Public Schools reserves the right to request qualification forms or additional information from any Bidder before issuing documents, receiving Bid Proposals or awarding an Agreement. Contractors agree not to discriminate against any employee or applicant for employment, with respect to their hire, tenure, terms, conditions or privileges of employment, or any matter directly or indirectly related to the employment, because of race, color, religion, natural origin, ancestry, age, sex, height, weight, material status, physical or mental handicap or disability. Contractor must require non-discrimination in employment, as herein specified, binding upon each subcontractor. This covenant is required pursuant to the Elliot Larsen Civil Rights Act, 1976 Public Act 453 as amended, MCL 37.2201, *et seq* and the Michigan Handicapper's Civil Rights Act, 1976 Public Act 220, as amended, MCL 37.1101, *et seq* and any breach thereof may be regarded as a material breach of the Agreement.**
11. Bid Proposals shall be on forms furnished by **Barton Malow Company in Section 00400**. Bidders will be required to submit with their Bid Proposals a Bid Security by a qualified surety authorized to do business in the state where the Project is located, an OSHA Form 300 (or 300-S) for the most recent completed year, their worker's compensation Experience Modification Rate (EMR) factor, and any other information required in the Instructions to Bidders. Bidders shall not withdraw Bid Proposals for a period of ninety (90) calendar days after date for receipt of Bid Proposals. Contractors must provide a 5% bid bond or security in the form of a cashiers check or bid bond.
12. The successful Bidder(s) will be required to enter into an Agreement with **Fraser Public Schools** on the Agreement Form identified in Section 00500 of the Project Manual.
13. The right to accept or reject any or all Bid Proposals, either in whole or in part, to waive any informalities or irregularities therein, or to award the Agreement to other than the low bidder is reserved by the Owner, in its sole discretion.
14. **All Bidders must provide familial disclosure in compliance with MCL 380.1267 and attach this information to the Bid Proposal. This Bid Proposal shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the Bidder and any member of the Board or the superintendent of the School District. The Owner will not accept a Bid Proposal that does not include this sworn and notarized disclosure statement. THIS FORM MUST BE NOTARIZED AND INCLUDED/ATTACHED WITH/TO THE BID PROPOSAL FORM OR THE BID PROPOSAL WILL NOT BE READ OR CONSIDERED! See project manual section 00400.**
