The matter having been brought before the Court, and Defendant Eric Joseph Smith having pleaded guilty to Official Misconduct in Office, contrary to MCL 750.505, to Tampering with Evidence, contrary to MCL 750.483a(6)(a), and to Conspiracy to Commit Forgery, contrary to MCL 750.157a and MCL 750.248; and,

Defendant Smith having testified under oath at the plea hearing to the facts supporting restitution and having agreed to make restitution in the amount and as provided herein, and the Court being otherwise advised in the premises.



**IT IS HEREBY ORDERED** that Defendant Eric Joseph Smith shall pay restitution to the Macomb County Circuit Court's restitution department in the amount of \$25,000 in favor of the Drug Forfeiture Account and the OWI Forfeiture Account, Macomb County Prosecutor's Office, referencing the above captioned case, court, and case number.

**IT IS FURTHER ORDERED** that this Order of Restitution shall remain in effect until satisfied in full, is a judgment against the defendant, and a lien against all defendant's property, which may be recorded as provided by law.

**IT IS FURTHER ORDERED** that this Order may be enforced in the same manner as a judgment in a civil action and may be enforced as a lien under MCL 791.1a and/or MCL 780.766(13).

**IT IS FURTHER ORDERED** that this Order may be enforced by the County of Macomb. Any person or entity enforcing this Order has all rights and relief under The William Van Regenmorter Crime Victim's Rights Act, MCL 780.751, *et seq.*, and under MCL 769.1a.
