STATE OF MICHIGAN, COUNTY OF GRAND TRAVERSE

To any peace officer or court officer authorized to make arrest: The complaining witness has filed a sworn complaint in this court stating that on the date and the location described above, the defendant, contrary to law,

COUNT 1: PROSTITUTION/ENGAGING SERVICES OF
did engage or offer to engage the services of another person, not his or her spouse, for the purpose of prostitution, lewdness, or assignation; contrary to MCL 750.449a(1). [750.449A]

HIV/STD TESTING NOTICE
Take notice that pursuant to MCL 333.5129, upon bindover to circuit court or recorder's court, the district court judge shall order the defendant to be tested for sexually transmitted infection, hepatitis B infection, and for the presence of HIV or an antibody to HIV if the judge determines there is reason to believe the violation involved sexual penetration or exposure to a body fluid of the defendant. If the district judge determines that testing is not required, upon conviction, the court must order the defendant to be tested.

MISDEMEANOR: 93 Days and/or \$500.00 (see MCL 750.451); mandatory AIDS/STD testing; court shall order law enforcement to collect DNA identification profiling samples.

COUNT 2: COMPUTERS - USING TO COMMIT A CRIME - MAXIMUM IMPRISONMENT OF 1 YEAR OR LESS
did use a computer program, computer, computer system, or computer network to commit, attempt to commit, conspire to commit, or solicit another to commit MCL 750.449(a)(1), prostitution, offering to engage the services for the purpose of prostitution; contrary to MCL 752.796, and MCL 752.797(3)(a). [752.7973A]

MISDEMEANOR: 1 Year and/or \$5,000.00; reimburse government for expenses incurred in relation to violation in manner indicated by MCL 769.1f (see MCL 752.797(7)). A consecutive sentence may be imposed for the underlying conviction.

Upon conviction, the court shall order law enforcement to collect a DNA identification profiling sample.
THE COURT FINDS probable cause to believe defendant committed the offense(s) set forth and that the following circumstance(s) apply:

- the complaint is for an assaultive crime or an offense involving domestic violence, as defined in MCL 764.1a.
- there is a reason to believe from the complaint that the person against whom the complaint is made will not appear on a summons
- the issuance of a summons poses a risk to public safety. the prosecutor has requested an arrest warrant.
