#### CBD/THC- Resident Rights

- . CMS Stance regarding Marijuana use:
  - . Recommend following state laws regarding storage and use;
  - Treated as a drug for abuse and/diversion;
  - Treated like a medication and smoking
- Ftags related to:
  - F755- Pharmacy Svcs/Procedures/Pharmacist/Records
  - . F761- Label/Store Drugs & Biologicals
  - . F602- Right to be Free from Misappropriation

#### Camera Usage in Nursing Homes

- Senate Bill 717 would allow for Electronic monitoring device
- F583 The resident has a right to personal privacy...
  - Photographs or recordings of a resident and/or his or her private space without the resident's, written consent, is a violation of the resident's right to privacy and confidentiality.
- "Virtual Sitters" What are facilities doing?
- Any best practices to share?

#### EBP for MDROs – CMS Guidance

- . IPRAT Webinar Very Helpful

  - Antibiotic Stewardship

#### EBP for MDROs – CMS Guidance

- Some discretion when implementing EBP and balancing the need to maintain a homelike environment
- . EBP is employed when performing high-contact resident care activities
- Discretion on how to communicate to staff which residents require the use of EBP
- . PPE and alcohol-based hand rub are readily accessible to staff

#### EBP for MDROs – CMS Guidance

- Gray areas = mini risk assessments
- . DOCUMENT, DOCUMENT, DOCUMENT
- Survey Process is not changed
- Resident Refusal
  - Educate
  - Document
