2. Chesterfield Pitstop LLC, 46963 Gratiot Avenue. Chesterfield, Chesterfield Township, Macomb County Complaint # CV-514536

The violation hearing was conducted for Chesterfield Pitstop LLC, Complaint # CV-514536. Kellie McGuire appeared on behalf of the Attorney Generals Office and Attorney Charles Shaw, appeared on behalf of the licensee. The licensing hearing was conducted for Los Ranchos, LLC, Request ID# 2211-14310. Rosendo Asevedo appeared on behalf of the Attorney Generals Office; Attorney Michael Brown with member Alfredo Melendez and applicant member Victor Manuel Bernal-De-La-Paz, appeared on behalf of the applicant.
