## Ordering WIDA Alternate ACCESS for ELLs Materials

Educators can still pre-identify students and obtain materials for the WIDA Alternate ACCESS for ELLs assessment. To pre-ID students for this assessment, use the directions found on the Office of Educational Assessment and Accountability OEAA Secure Site Training page (www.michigan.gov/securesitetraining) under the Pre-Identification of Students section. The student's Tier must be updated to "Tier T".

**Note:** Pre-identifying students in the OEAA Secure Site will not result in the automatic delivery of materials from the assessment vendor, Data Recognition Corporation (DRC), at this time. To receive materials, educators must place an Additional Material Order in WIDA AMS when the Additional Material Order window opens on January 23.

## Bubbling-in Student Information on WIDA Test Booklets

Districts and educators are reminded that even if a Pre-ID label is affixed to the student test booklet, some information must be bubbled-in by hand. If a student's pre-printed label is damaged or falls off and the minimum amount of information is not bubbled-in on the booklet, there is a risk that DRC and the Michigan Department of Education (MDE) will be unable to match a test booklet to the particular student.

#### **WIDA Incident Reports**

If testing irregularities occur before, during, or after testing, the Building or District WIDA Coordinator must report the irregularities to the Office of Educational Assessment and Accountability (OEAA) as soon as possible. A WIDA ACCESS for ELLs and Alternate ACCESS for ELLs Incident Reporting (IR) Reference Table (https://www.michigan.gov/mde/-/media/Project/Websites/mde/OEAA/WIDA-Assessments/23-WIDA-Incident-Report-Table.pdf) is available to help coordinators in this process. The guide identifies the incident categories and sub-categories used in the Secure Site Incident Reporting tool and includes sample scenarios for each category or sub-category.

#### Screening Potential English Learners During the WIDA ACCESS Testing Window

Michigan schools are still federally required to screen newly enrolled students who have not been previously identified as English learners (ELs) using the WIDA Screener, even if the WIDA ACCESS for ELLs testing window is open.

If, while the WIDA ACCESS for ELLs testing window is open, a student is determined to be an EL – per the criteria outlined in Michigan's Entrance and Exit Protocol (EEP) (https://www.michigan.gov/mde/-/media/Project/Websites/mde/OES/Programs/Title-III/EL\_Entrance\_and\_Exit\_Protocol.pdf) – the summative WIDA ACCESS for ELLs or the WIDA Alternate ACCESS for ELLs assessment must be administered to that student.

The OEAA strongly recommends that students be allowed as much time as possible between the WIDA Screener and the summative test, to ensure students do not experience testing fatigue.

#### WIDA Additional School/District Labels

By now, most schools and districts should have received an adequate supply of School/District Labels. However, if any schools/districts need to order additional labels, the district must send an email to <a href="mailto:mde-oeaa@michigan.gov">mde-oeaa@michigan.gov</a> with the following information, so the OEAA can request a shipment of those materials from DRC (the testing vendor):

- · District Name
- · School Name
- Quantity of School/District Label Sheets (1 sheet = 10 labels)

#### Overdue for Submission to ISDs – Local 1% Alternate Assessment Justification Forms

Note to special education personnel in local districts and public school academies:

District-level 1% alternate assessment justification forms (submitted through the special education application Catamaran) are now overdue and should be submitted as soon as possible.

Intermediate School District (ISD)-level justification forms are due to be submitted to the Michigan Department of Education (MDE) by tomorrow, January 24, 2025. The ISDs cannot submit their forms to MDE until they have received the local justification activity forms from each of their local districts/public school academies.

Test Coordinators should review these resources in preparation for testing and ensure that proctors and other test staff review the necessary publications prior to test day.

#### Using the Floating Accessibility Menu on Chromebooks

For Spring 2025 College Board (CB) testing text-to-speech will be available as an embedded tool for all testing students with the approved text-to-speech (embedded) accommodation in Services for Students with Disabilities SSD Online (https://ssdonline.collegeboard.org/). This means no special configuration of the testing device is required for students using embedded text-to-speech as they take the CB tests.

For Chromebook users, this means the floating accessibility menu does not need to be turned on for embedded text-to-speech. However, for other features, such as a large mouse cursor, the accessibility menu must be enabled.

**Note:** Enabling the floating accessibility menu affects all programs on the Chromebook, including other state tests. The accessibility menu may provide non-standard Accommodations on WIDA assessments, MI-Access, and M-STEP or may even interfere with approved standard Accommodations on these assessments.

To avoid interference with other testing programs, consider assigning extra Chromebooks to a unique organizational unit (OU) and reserving them for students who need the floating accessibility menu features.

If enabling the floating accessibility menu on all Chromebooks is the only option, monitor testing to ensure that students are not using accommodations for which they are not approved, and turn off the Kiosk floating accessibility menu on all testing devices once CB testing is completed.

#### Stay Updated with College Board's Latest Bluebook Releases

A critical update to the Bluebook™ digital testing application was released on



January 6, 2025. Bluebook will auto-update the next time it's opened on a student's testing device, unless the school's technology staff have blocked auto-updates.

If your school's managed devices don't allow Bluebook auto-updates, technology coordinators must perform manual updates to make sure testing devices are running the latest version of Bluebook. Collaborate with your technology coordinator to ensure Bluebook is up-to-date on all testing devices prior to test day. Remember to check for new releases every Friday on Bluebook Updates (https://bluebook.collegeboard. org/technology/updates).

To avoid overwhelming your school's testing network and causing delays, ensure that students open Bluebook on their devices prior to test day. This step is part of College Board's digital readiness check, which College Board advises schools to complete 1-2 weeks in advance of testing.

## Spring SAT Suite Pre-ID Window

The Michigan
Department of
Education's student
Pre-Identification



(Pre-ID) window for Spring SAT Suite testing is open through February 14, 2025. Pre-ID for late-arriving students and for other unforeseen changes in student enrollment can be completed from February 15 to April 23 for online testers, and from February 15 to April 21 for paper/pencil testers, as well as for any online testers approved for multi-day testing.

College Board will pull Pre-ID data from the Office of Educational Assessment and Accountability (OEAA) Secure Site beginning on February 17 through April 23 for digital testers, and from February 17 through April 21 for paper/pencil testers. Student registrations will appear in College Board's State Data Management System (SDMS) one business day after each data pull, and in the Test Day Toolkit two business days after each data pull.

## Access to Test Day Toolkit and SDMS

- February 3: School test coordinators will receive access to Test Day Toolkit
- February 19: District test coordinators, school test coordinators, and Services for Students with Disabilities (SSD) Coordinators will gain access to SDMS

Test staff will be notified via email about their access to each application.

#### State Allowed Accommodations Window Open, Will Close February 18

The window for entering State Allowed Accommodations (SAAs) in SSD Online



(https://ssdonline.collegeboard. org/) is now open. The deadline for entering all accommodations in SSD Online, including SAAs, is

February 18, 2025.

**Note:** SAAs, while permitted by the Michigan Department of Education, are not considered approved accommodations by College Board. For that reason, scores obtained with SAAs are not college-reportable.

#### **Pre-identify Students and Order WorkKeys Test Materials**

The window to submit student data for pre-identification barcode labels and to order ACT WorkKeys standard-time and accommodations materials is open through **February 14, 2025** (5:00 p.m.) through the Office of Educational Assessment and Accountability (OEAA) <u>Secure Site</u> (https://www.michigan.gov/oeaa-secure).

Instructions for these activities can be found on the <u>Secure Site Training web page</u> (www.michigan.gov/securesitetraining) under the **Pre-Identification of Students** and the **Material Ordering** sections.

Initial material orders for Standard Time, Regular Print WorkKeys materials will be based on the number of students pre-identified on the OEAA Secure Site by 5:00 p.m. on February 14, 2025.

The projected number of Standard Time, Regular Print materials that will be sent to the school(s), based on the pre-identification count, can be viewed on the Initial Material Orders page on the OEAA Secure Site. The number of Standard Time, Regular Print materials can only be adjusted by pre-identifying additional students and/or unassigning students from the testing. Accommodated and Spanish materials orders will automatically reduce the number of Standard Time booklets sent.

**Important:** Accommodated materials and Spanish test booklets must be ordered (if needed) through the OEAA Secure Site on the Initial Material Orders page by 5:00 p.m. on February 14, 2025. Missing this deadline will result in your school not receiving ancillary accommodations and return shipping materials.
