Recent Data: National and State Trends

- Nationally: A decline on three tests (both reading tests and 8th grade math) and an increase on one (4th grade math).
- Nationally: The two declines in reading were statistically significant.
- Michigan: A decline on the same three tests as nationally and an increase on the same test (fourth grade math) as nationally. NONE of the results were statistically significant.
- Michigan is one of 29 states whose improvement or decline in scores from 2022 to 2024 was not statistically significant in either grade or either subject.



The Committee for Literacy Achievement/HQ Literacy Materials Grant





Professional Development	Requires the CLA, in collaboration with MDE, to create and maintain a rankings list of professional development	Requires MDE to develop a literacy coaching model that includes grades 4 - 12
Curriculum	Requires the CLA, in collaboration with MDE, to create and maintain a rankings list of all early literacy series	Requires MDE to publish a list of evidence-based tier 1, class-wide reading curricula and materials that are aligned with the Science of Reading

Mandatory LETRS Training

- 3,175 educators have completed LETRS training
- 6,804 educators are actively participating in LETRS training
- Grounded in the science of reading research and structured literacy
- Training directly aligns with the requirements for professional development outlined in Public Act 146 of 2024
- Provides professional development for educators in the five main components of literacy (phonics, phonemic awareness, comprehension, fluency, and vocabulary)
- Accredited by the International Dyslexia Association
