ARCHIVES OF MICHIGAN



Kent County was organized in 1836. The county coordinates are Ranges 9 West through 12 West (9W-12W) and Townships 5 North through 10 North (5N-10N). Adjacent counties include Newaygo (north), Montcalm (northeast), Ionia (east), Barry (southeast), Allegan (southwest), Ottawa (west), and Muskegon (northwest).

Original records from Kent County are available at the Archives of Michigan. The list below is organized by record type; each record type lists specific records, the years of coverage and the record group (RG) number assigned to that collection.
