

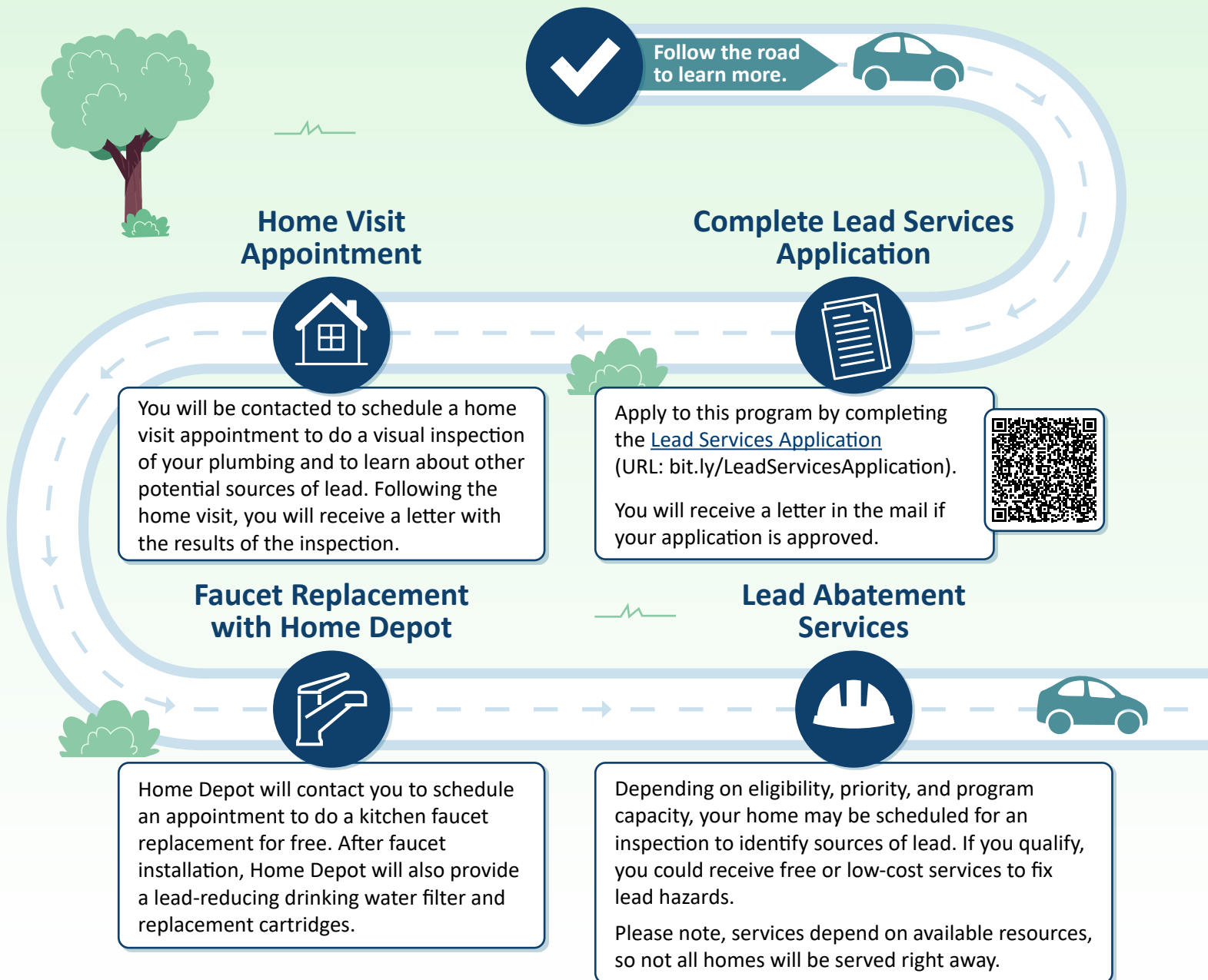
The Faucet & Filter Safety Net Program

can provide the following for eligible households:

- Lead-reducing filter.
- Replacement cartridges.
- A home visit and a visual plumbing assessment.
- A single faucet replacement.
- Assistance applying for the Michigan Department of Health and Human Services (MDHHS) Lead Abatement program.

Home Visit Appointment



You will be contacted to schedule a home visit appointment to do a visual inspection of your plumbing and to learn about other potential sources of lead. Following the home visit, you will receive a letter with the results of the inspection.

You will receive a letter in the mail if your application is approved.

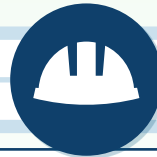


Faucet Replacement with Home Depot



Home Depot will contact you to schedule an appointment to do a kitchen faucet replacement for free. After faucet installation, Home Depot will also provide a lead-reducing drinking water filter and replacement cartridges.

Lead Abatement Services



Depending on eligibility, priority, and program capacity, your home may be scheduled for an inspection to identify sources of lead. If you qualify, you could receive free or low-cost services to fix lead hazards.

Please note, services depend on available resources, so not all homes will be served right away.



To be eligible for the Faucet and Filter Safety Net Program, the household must:

Be located in one of the following communities:

- City of Albion.
- City of Benton Harbor.
- City of Detroit.
- City of Ecorse.
- City of Flint.
- City of Hamtramck.
- City of Highland Park.
- City of Inkster.
- City of Muskegon Heights.
- City of Pontiac.
- City of Saginaw.

AND

Include a Medicaid-enrolled child or children under 19, or Medicaid-enrolled pregnant person.
