Treasury Department Report Motor Carrier Advisory Board (MCAB) Meeting on September 21, 2023

The Michigan IFTA tax system platform change occurred on September 15, 2023. Log in credentials stayed the same although some users may need to reset their passwords (it's been hit & miss). The feedback thus far has been satisfactory, and customers have been very cooperative in the change. A previous bookmarked link to the old system will not work although the landing page will provide the new web address as does our Michigan.gov/IFTA page. Since October will be the filing month for the 3rd quarter tax returns, we will be sending out reminders to licensees to file early rather than waiting till the very end of the month as we expect the number of incoming phone calls to be high.

Georgia has implemented another tax holiday that will not be reflected on the tax returns. There is no tax on fuel purchased in Georgia from September 13, 2023, to October 12, 2023. Therefore, the miles traveled in Georgia during this period should be reported in the total miles for Georgia but deducted from the taxable miles for Georgia. Any fuel purchases in Georgia during this period should be reported as non-IFTA fuel with a reason as "Georgia tax holiday". Do not report this fuel as tax paid as credit is not eligible for tax paid fuel however the gallons are needed to be reported as non-IFTA to determine the appropriate fleet MPG calculation.

Indiana has also reported an error for 3Q 2023 tax rates on fuel. Since the error was reported early enough for us to enter it in our Michigan IFTA system, the Indiana rates are correct when filing your return however the IFTA Inc website tax matrix is not correct.

Newfoundland has also reported an error in submitting tax rates to IFTA Inc. for the 3Q 2023 and they did not report this early enough for us to change it in our system. Therefore, Newfoundland has the responsibility to pursue tax discrepancies on their own accord.

2024 decals (red) have been received and are ready to go so there will be no delays for Michigan in distributing them starting November 1, 2023, when renewal season begins.

Finally, with more jurisdictions passing legislation on taxing of electric as a fuel for qualified carriers, Indiana passed legislation to implement a mileage-based tax on electric vehicles starting in 2024. The IFTA jurisdictions are in heavy discussions on how to implement this taxing process in our current tax reporting processes and the ideas are abundant. More to come on these developments.

Trucking-related Bills in the 102nd Michigan Legislature – 2023-2024

Passed means passed house of origin. Enrolled or presented means passed both houses. P.A. Number ___ means enacted into law.

Senate

275 CLEAN-FUELS MANDATE (Singh+14) Apply second tax to vehicle fuels and use revenue to subsidize biofuels and electric vehicles. Prohibit petroleum fuel sales unless accompanied by purchase of credits from biofuels or electrification spending, to achieve statewide carbon-intensity standards. Applies to all vehicle fuels, including off-road Diesel, bus, farm, train, ship, and aviation fuel.

Tax rate unknown, but possibly 10 to 50 cents/gallon; to be set administratively by DEGLE based on spending to avoid carbon emissions. Revenue to be directed to electric-vehicle subsidies, vehicle-charger and infrastructure installation, biofuels, renewable fuels, and other spending.

Require carbon intensity of vehicle fuels to be reduced 25% below 2019 levels by 2035, or more

House

- 4028 TOW TRUCKS, SPRING WEIGHT RESTRICTION (Zorn) Amend Subsec. 722(8) to exempt tow trucks from seasonal weight restrictions, when traveling light or towing a disabled vehicle. Same as 101st SB 640. Hearing held.
- 4132, 4133 WORK-ZONE SPEED CAMERAS (Snyder+1 of both parties; MITA bill.) Authorize MDOT or MSP (not local units) to use speed cameras in trunkline work zones. Require notification signs. Create new civil infraction of an "individual" (not person) violating a work-zone speed limit by 10 mph while workers are present. (Unclear if "individual" includes a corporation, like a trucking company.)

Registered owners or lessees are presumed responsible; may rebut presumption by mail if the owner was not driving—not required to identify driver. Citations to be delivered by first-class mail. Passed House.

- 4250-4252 HAND-HELD CELL PHONES (Koleszar+8 of both parties) Prohibit use of any hand-held "mobile electronic device" while driving. Allow use of navigation devices if data are not entered by hand. Allow emergency use. Allow voice-activated phones built into or attached to a vehicle, and hand activation of a phone feature or selection of a phone number by a single touch. Exclude CB and 2-way radio, and parked vehicles. Prohibit use of social networking sites and watching video. Allow primary enforcement stops; prohibit searches of vehicles. Effective June 30, 2023. P.As 39-41 of 2023.
- 4352, 4353 CARPOOL LANES on I-75 (Shannon+2) Authorize MDOT to restrict newly-built lanes to HOVs, trucks, or other classes of vehicles (as on I-75 in Oakland County). Authorize enforcement. Reported to Senate.
- 5023 CITY TOWING MANAGEMENT (Farhat+19) Prohibit local governments from contracting with third parties to manage and administer towing operations or impound lots.

Court Decisions

I.RP. and NO-FAULT In *Frankenmuth Mutual Insurance Company v. Michigan Automobile Insurance Placement Facility* (COA Docket No. 362955), Court of Appeals finds that no-fault coverage is required by IRP trucks based in other states if they operate in Michigan more than 30 days in a calendar year.
