Unfinished Business

MVTF Director Holm reported that he will be traveling to Texas January 21-24, 2025, with MVAA Director and MVAA Deputy Director to discuss the Texas home loan programs for veterans. Director Holm also gave an update on the VFW National Home Regenerative Agriculture Demonstration Farm program, adding that they have four members that are currently going through the program who will be presenting their project proposals for the year-long cohort. Holm added that the Home will have an advisory board; two members from the MVTF, two members from MDARD, and three members from the VFW National Home that will be overseeing and making decisions on the program. Holm also reported that he is hopeful to get an agent to volunteer at the Home that will to assist taking Trust Fund applications at the VFW National Home. Director Holm reported that he submitted the MVTF Annual Report, a brief discussion followed. Director Holm gave an update on the status of gubernatorial appointments specifically the MVTF Board members whose terms are ending and the vacant board spot. A brief discussion followed.

Vice Chairperson McIvor reported that he will be attending his mid-winter conference January 29-31, 2025, to be held in Kalamazoo Michigan. Chairperson Wallace reported that he will be attending the American Legion Conference in Port Huron February 7-9, 2025. Chairperson Loonsfoot reported on the first Annual National American Indian Charter that is the first congressionally charted Native-American VSO. A brief discussion followed. Chairperson Loonsfoot reported that he attended a Tribal Leaders Summit in Washington, D.C. last month where he represented the Michigan tribal community at the White House Tribal Summit, adding they met with Congressional leaders to promote tribal interests. Trustee Loonsfoot gave an update on the Toys for Tots campaign in the Upper Peninsula which ended in December. Loonsfoot reported that the Toys for Tot's campaign raised over \$30,000.00. A brief discussion followed.

Director Holm reported that MVTF Outreach Analyst, Erik Napieralski is attending a SalesForce meeting today.

MVTF Director Holm reported on a veteran who received a grant from the MVTF. The veteran sent a heartfelt letter thanking the MVTF for assisting him with his dental needs that had been ongoing for years. Because of the MVTF grant, the veteran was able to get all the dental work completed and is now out of pain. A brief discussion followed. Chairperson Dempsey reported that he offered to be an advocate to a peacetime veteran who is in dire need of assistance and has several ongoing health issues. Chairperson Dempsey has also offered to drive this veteran to Ann Arbor to meet with his social worker tomorrow.
