## ABOUT US

The 15-member Michigan Women's Commission (MWC) was created by statute in 1968. Commission duties include reviewing the status of women in Michigan, directing attention to critical problems confronting women, and recognizing women's accomplishments and contributions to Michigan. Commissioners are appointed by the Governor and serve threeyear terms.

## Public Meeting

MWC held one public meeting in FY24 on April 16 in Jackson, MI.

Prior to the public meeting, MWC hosted a roundtable to promote pathways to high wage jobs for women focusing on Consumers Energy's skilled trades apprenticeship program. MWC was joined by guest speakers Melissa Gleespen, Chief Compliance Officer for Consumers Energy, Christina DuVall, Executive Director of Ethics and Compliance for Consumers Energy, and Trisha Schlegel, Economic Analyst for the Michigan Center for Data and Analytics (MCDA). Gleepsen and DuVall shared how Consumers Energy supports women in their apprenticeship programs. Schlegel presented the key takeaways from the 2024 Women in the Michigan Workforce Report (PDF) including Michigan women earn less than men regardless of full- or part-time work; the number of women in the Michigan labor force has recovered more slowly than men, and on average, women in Michigan are more educated than men.

## **Committees**

Financial Freedom Committee, chaired by Commissioner Dr. Tracy Joshua, focuses on actions to close gaps and increase access to income. Examples include pay equity and access to education and training for high wage jobs.

Unlocking Opportunities Committee, chaired by Commissioner Karin Hopman, pursues initiatives to eliminate barriers to work. Examples include increasing the availability of affordable childcare, expanding paid leave and menopause in the workplace initiatives.

Visible Authentic Leadership Committee, chaired by Commissioner Vivian Pickard, explores policies that will increase the number of women serving in publicly visible leadership roles across sectors. Examples include incentives for promoting more women into corporate executive leadership, increasing the number of women serving on corporate, foundation and nonprofit boards, and encouraging more women to run for elected office at all levels of government.

# Program Highlights:

## MI Tri-Share Child Care Program

The MI Tri-Share Child Care Program (MI Tri-Share) is an innovative approach to increasing access to high quality, affordable child care for working families, while also helping to retain talent and removing one major barrier to employment. Through MI Tri-Share, the cost of child care is shared equally by an eligible employee, their employer, and the State of Michigan, with coordination being provided regionally by a facilitator hub. MI Tri-Share was made a permanent ongoing program with the state's FY23 budget and was transferred to the new Department of Lifelong Education, Advancement, and Potential (MiLEAP) in 2024.

While this work no longer falls under the Women's Commission, we are please to share that thanks to our efforts to launch this program, participation grew almost 100% between employers, employees and child care providers as of FY24. The program saw constant growth with 97% of families saying that participating in the program improved their financial stability. Additionally, 80% of the families agreed that the program helped them continue working in their current job. And of that 80%, 73% of families agreed that the program helped them program helped them continue working in their current job.

## MWC Bipartisan Legislative Women's Council

We launched the MWC Bipartisan Legislative Women's Council ("Women's Council") in early 2022 to facilitate greater communication and collaboration between MWC and women elected to Michigan's House. The Women's Council updates legislators on MWC's programs and resources to share with their constituents and facilitates collaboration with the Michigan Legislature to advance economic security and opportunity for all of Michigan's women.

On Dec. 4, 2024, the Women's Council held a workshop for the Women's Council led by Anne Mervenne, Vice-Chair of the Michigan Council of Maternal & Child Health (MCMCH) and board member of the Children's Center in Detroit and Amy Zaagman, Executive Director of the MCMCH and Vernice Davis Anthony, former director of the Michigan Department of Health, about maternal mortality and how policy change can support better birth and maternal health outcomes.

## 21-Day Racial Equity Challenge

The 21-Day Racial Equity Challenge (21-Day) was created by and shared in partnership with the Michigan League for Public Policy to learn about the origins of race, how it influences communities and organizations and how it functions to preserve inequity in laws, institutions and systems. MWC is working with a scholar from Michigan State University to create a similar initiative that will address gender equity.

**Oct. 18, 2023:** MWC collaborated with the Office of the Attorney General to debut and promote Michigan's new Address Confidentiality Program designed to help those at risk of harm by shielding the actual physical address, providing an official designated/substitute address and free mail forwarding service. Jan. 27, 2024: In collaboration with the Girl Scouts of Southeastern Michigan (GSSEM), MWC hosted the first in-person badge earning event of the mentorship program. The program paired older Girls Scouts with commissioners to teach them about women leadership in government and create lasting relationships that will enrich both the mentors and the mentees. In addition to the mentorship program, all levels of Girl Scouts were able to learn about women leadership in government by attending an in-person badge earning event and/or tuning into a Friday Night Live (FNL), a virtual speakers' series. The in-person badge earning event: Democracy & Me featured keynote speaker Secretary of State (SOS) Jocelyn Benson in Detroit. Secretary Benson taught the girls the various functions and branches of government and highlighted the impact women have in the system, historically and in the future. (<sup>Δ</sup>)

**March 18, 2024:** MWC debuted the 2024 Women in the Michigan Workforce Report (PDF) created in partnership with the Michigan Center for Data and Analytics (MCDA) The report aimed to highlight key factors that contribute to challenges women in the workforce face. Discrepancies in average pay, hours worked, and labor force participation were some of the areas highlighted. This report succeeds the 2021 Women in the Michigan Workforce Report (PDF) with an expanded focus on education, training and regional information. To celebrate its release, MWC produced a webinar featuring Gov. Gretchen Whitmer, moderated by Chair Williams, and guest speaker Trisha Schlegel, author and economic analyst for the MCDA.
