SUBJECT: Wolverine World Wide, Inc. (WWW) PFAS Response Identification and Investigation of Reported Disposal Areas Various Locations, Kent County, Michigan

The Department of Environmental Quality (DEQ) has received information indicating that WWW disposed of waste materials potentially contaminated with per- and polyfluoroalkyl substances (PFAS) at multiple locations in Kent County. The DEQ is requesting that WWW take measures to mitigate potential public health risks and assess these sites by performing the following response activities:

- 1. Sample and analyze drinking water at all potential receptor locations;
- 2. Provide an alternative water source to property owner/tenants where sampling has occurred; and
- 3. Provide the DEQ with a Work Plan for a remedial investigation and proposed remedy for managing WWW-generated waste material by November 20, 2017. (Where there are physical remnants of dumping, a geophysical survey of property with Electromagnetic and Ground Penetrating Radar may be necessary to fully assess the extent of the potentially buried waste on the property.)

The locations the DEQ is requiring response activities in this letter fall into two general categories: Sites that have been investigated and physical remnants suggest WWW dumping; or Sites where the DEQ has received information from property owners indicating that WWW waste has been historically disposed of on the property, but no physical remnants are present. Further information regarding these sites is provided below.

Also note, pursuant to our November 2, 2017, project coordination meeting with GZA and WWW, the DEQ requested that a Work Plan for the remedial investigation of the Jewell Street locations be submitted by November 6, 2017; the DEQ received the Work Plan on November 6, 2017.
