Re: Wolverine Worldwide, Inc. – Rogue River Sampling Area Proposed Scope of Work

Dear Ms. Hendershott:

As requested on December 15, 2017, Rose & Westra, a Division of GZA GeoEnvironmental, Inc. (R&W/GZA) is presenting this proposed scope of work (SOW) on behalf of Wolverine World Wide, Inc. (Wolverine). This SOW pertains to the request in the December 15 letter to sample wells along the Rogue River. As you know, we submitted a technical evaluation letter on December 11, 2017, and our evaluation of the available data and hydrogeological conditions suggests any areas of potential impact from possible PFAS in the Rogue River are limited to a few select areas. We continue to believe the conclusions reached in our technical memorandum are accurate but, in the interest of cooperation with the MDEQ and other involved agencies, Wolverine agrees to sample the attached December 15, DEQ-RRD Rogue River Sampling Area.

To evaluate the investigation area established by the MDEQ, Wolverine proposes to notify, provide alternate (bottled) water (pending results), and sample the residential wells within said area. We anticipate this will be approximately 300 residential wells. Notifications and bottled water deliveries began Tuesday, December 19, 2017. Notifications in the area identified as "Expansion to House Street Sampling Area" on the attachment will be completed by December 22, 2017. Notifications in the area identified as "Tannery Sampling Area" will commence on January 2 and are expected to take 2 to 3 days.
