

November 2010 Summary

U.S. Economy: The ISM manufacturing index increased 2.9 points from a year ago while the ISM non-manufacturing composite index rose 6.6 points. Both ISM indexes have signaled expansion since January 2010. Consumer sentiment rose 3.9 points from October and was up 4.2 points from last year. Both industrial production and capacity utilization (three-month averages) rose for the 17th straight month. Overall retail sales were up 7.7 percent from last year. November housing starts were down 5.8 percent from last year while existing home sales were off

27.9 percent.

Employment: In November. Michigan employment fell by 6,300 jobs from last month and was down 19,200 jobs from a year ago. National employment increased by 39,000 jobs from October. Falling by 0.4 of a percentage point to 12.4 percent, the November 2010 Michigan unemployment rate represented the state's lowest rate since February 2009. The U.S. rate rose from 9.6 percent to 9.8 percent.



Auto Industry: In November, the

light vehicle sales rate was unchanged from October at a 12.2 million unit annual rate. Light vehicle sales were up 12.8 percent compared to a year ago. Vehicle inventories were up 22.0 percent from a year ago but days supply was up by only five days. In November 2010, Michigan vehicle production (three-month average) rose 6.5 percent compared to a year ago; the national vehicle production average increased 6.9 percent.


Inflation: Compared to a year ago, the U.S. consumer price index (CPI) was up 1.1 percent. The core U.S. CPI (excluding food and energy) rose 0.8 percent. The overall producer price index rose 3.5 percent but the core producer price index increased only 1.3 percent. At \$84.14 per barrel, oil prices were up \$6.06 a barrel from November 2009.

Michigan Metro Areas: Unemployment rates fell in all 17 Michigan major labor markets in November compared with year ago levels. All areas saw at least a 1.5 percentage point rate decline. Employment rose in eight labor market areas, fell in eight areas and remained unchanged in one area.

Labor Market Statistics

• Michigan's November unemployment rate decreased 0.4 percentage points from last month to 12.4 percent, and the current Michigan jobless rate is down 2.0 percentage points from a year ago. The November U.S. unemployment rate increased 0.2 percentage points from October to 9.8 percent and was down 0.2 percentage points from a year ago. Monthly unemployment rates fluctuate in part due to statistical sampling errors and data revisions.

- In November, the number of people employed in Michigan was 4,202,000, up 2,000 from last month, while the labor force decreased by 19,000. The statewide total number of unemployed decreased by 22,000 to 597,000.
- United States household employment totaled 138.9 million persons in November, down 173,000 from October. The labor force rose by 103,000 from last month, which meant there were 276,000 more unemployed people nationally, compared to October.



Employment by Place of Work

• From November 2009 to November 2010, Michigan wage and salary employment decreased 19,000 (0.5 percent). State wage and salary employment decreased 6,000 from October. Nationally, November 2010 wage and salary employment rose 842,000 (0.6 percent) from a year ago and was up 39,000 from last month.

- In the goods-producing sector, Michigan employment increased 0.9 percent from a year ago while private service-producing sector employment decreased 0.2 percent compared to last year. From a year ago, November national employment in the goods-producing sector rose 0.4 percent and increased 1.1 percent in the private service-producing sector.
- Manufacturing weekly hours increased 0.3 hours in Michigan compared to last year.



Motor Vehicle Industry Sales

- At a 12.2 million unit rate, November 2010 light vehicle sales were unchanged from October 2010. November 2010 light vehicle sales were up 12.8 percent from a year ago.
- Compared to October 2010, November 2010 domestic sales increased 0.2 percent while foreign sales fell 0.4 percent. Domestic sales rose 11.6 percent compared to a year ago while foreign sales increased 16.7 percent. Consequently, the foreign share of U.S. light vehicle sales increased 0.8 percentage points from a year ago to 24.7 percent.
- Auto sales rose 0.7 percent compared to October 2010 and increased 4.3 percent compared to a year ago. Light truck sales decreased 0.6 percent from October and jumped 21.9 percent from November 2009. Heavy truck sales were up 0.9 percent compared to a year ago.
- In November 2010, light vehicle inventories rose 3.4 percent from October and were up 22.0 percent from a year ago. Days supply was down 1 day from October and was up 5 days from a year ago.



Motor Vehicle Industry Production

- At 121,858 units, November 2010 Michigan motor vehicle production rose 10.0 percent from last November. National production rose 5.3 percent in November. Compared to October 2010, Michigan production decreased 24.3 percent while national production was down 11.4 percent.
- Michigan car production fell 16.4 percent from a year ago while State truck production increased 27.8 percent. Nationally, car production fell 4.1 percent while truck production increased 11.7 percent.
- From a year ago, Michigan's share of national production rose 0.8 percentage points to 19.3 percent.

Local Area Unemployment Rate Falls In All Seventeen Local Areas

(Not Seasonally Adjusted)

November 2010 area unemployment rates ranged between 7.2 percent (Ann Arbor MSA) and 14.6 percent (Northeast Lower Michigan). The median unemployment rate was 10.9 percent.


Compared to a year ago, the unemployment rate fell in all seventeen major Michigan labor market areas with the rate falling by at least 1.5 percentage points in each area. The median unemployment rate decline was 2.0 percentage points. The Monroe MSA saw the largest rate decline (-3.5 percentage points) followed by the Muskegon-Norton Shores MSA (-3.2 percentage points) and the Detroit-Warren-Livonia MSA (-3.0 percentage points).

Between November 2009 and November 2010, eight labor market areas saw an employment increase; eight realized a decline and one saw no change. The Detroit-Warren-Livonia MSA experienced the largest employment increase (2.7 percent), followed by the Grand Rapids-Wyoming MSA (1.0 percent). The Bay City MSA and Northeast Lower Michigan each reported the largest year ago employment decline (-2.2 percent) followed by the Holland-Grand Haven MSA (-1.2 percent). Compared to a year ago, the labor force fell in all seventeen areas with the Monroe MSA experiencing the largest decline (-4.5 percent) followed by Northeast Lower Michigan (-4.4 percent). The median labor force decline was a 2.4 percent drop.

Between November 2009 and November 2010, the unemployment rate fell in 80 Michigan counties with a median rate decrease of 2.1 percentage points. Lapeer County posted the largest decline (-4.3 percentage points) followed by Baraga County (-3.7 percentage points). The three counties that saw rate increases reported only slight to modest increases. Fifteen counties saw a November 2010 unemployment rate below 10.0 percent. Thirteen counties reported rates higher than 15.0 percent.
